national security threats

Policy Relevance

Intelligence and security agencies should closely monitor the activities of Iranian proxies, particularly the Houthis, for signs of increased aggression or strategic shifts. The potential for regional escalation remains high, and stakeholders should be prepared for rapid changes in the geopolitical landscape. Enhanced intelligence sharing and regional cooperation could help mitigate risks associated with these dynamics.
